-- as field advances arise with the rapid pace of new inquiries. Facing this tremendous promulgation and diversification of SNA, this book distills essential
frontiers across fields. Introducing emerging issues in the application of social network theory and SNA, and how these can or will be addressed, each chapter
illuminates new trends or applications of a social network approach that can have wide potential impact in other disciplines. Conceptual advances (e.g.,
applying the concepts of social networks such as peer influence on disease management and treatment adherence), as well as novel analytic approaches for
studying properties of social networks are highlighted. This book constitutes a collection of articles that were written for, and recently published as, special

understanding of the complex data sets often encountered in the measurement and study of personality. These articles serve as both an introduction and a brief
tutorial for personality researchers who are unfamiliar with the subject matter. They are valuable references that will form the basis for evaluating the
